Privacy Statement

Doing business with an insurance broker involves providing information about yourself, whether you are requesting a quote, purchasing a policy, revising your policy, or seeking advice. Insurance is to a great extent based on a foundation of trust between you, your insurance broker, and the insurance companies. You can be assured that TG Group Inc. will always handle your information responsibly.

At TG Group Inc., we follow the Code of Conduct legislated under the Registered Insurance Brokers Act with respect to the use of your personal information. Information obtained during our professional relationship concerning your business and affairs is kept strictly confidential and released only if you authorize it, or the law requires it, or we need it to transact business on your behalf.

Web site Information

We may gather and store data on our website users' activities. This is done on a collective rather than individual basis, so you can be certain that your specific activities are not "monitored."

The above are only examples. Generally, such disclosures are made only rarely, or not at all. It is our practice to provide only as much information as is reasonably necessary to accomplish the intended purpose.
